the Circuit Court, died of a heart attack Sunday while walking in the 1400 block of N. Lake Shore.

Coroner Andrew J. Toman said an autopsy showed the 73-year-old jurist died of "massive, acute coronary thrombosis due to hardening of the arteries."

His family said he had been under treatment for arterial sclerosis but had continued his habit of taking walks of three to four miles.

Visitation will be from 8 a.m. to 10 p.m. Tuesday at the Carroll Home for Funerals, 25 E. Erie.

Judge Bowe, who lived at 1120 N. Lake Shore, was noted as a champion of improved race relations, preservation of architectural landmarks and encouraging the arts.

Surviving are the widow, Julia; a son, John, a Chicago lawyer, and a daughter, Mrs. Willard Q. Thompson of Cleveland.

The requiem mass will be said by the Very Rev. Msgr. Daniel M. Cantwell, chaplain of the Catholic Interracial Council.

Judge Bowe **Rites Held** Wednesday

Mass for Judge Augustine J. Bowe, 73, of 1120 Lake Shore, presiding judge of the Municipal Division of Circuit Court, was held yesterday (Feb. 9) at Holy Name Cathedral. Burial was in Calvary Cemetery.

Judge Bowe died Sunday, Feb. 6, during a pre-dinner stroll near his home, after he had collapsed in a snow bank.

He was pronounced dead of an apparent heart attack in Henrotin Hospital. Since he carried no identification, the body was taken to the county morgue, where it was identified three hours later by his widow, Julia, and his son, John, 2431 Orchard, an attorney.

Judge Bowe collapsed in front of an apartment building at 1430 Lake Shore. He was discovered lying in the snow by Fred Hunley, a car hiker in a garage in the building. Hunley called police. "Chicago has lost one of its

greatest citizens with the death of Judge Bowe. As a lawyer, judge, humanitarian and patron of the aris, he made outstanding contributions to the city and its people," Mayor Daley said.

Judge Bowe was president of the Chicago Bar Association in 1955 and 1956. He became chief justice of the Municipal Court in 1960 and held that post until January, 1965, when a judicial reform amendment became effective and since then held the position he had at the time of his death.

A writer of many poems, Bowe, when a sophomore in law school, helped Harriet Monroe found Poetry magazine. He became president of the Modern Poetry Assotion.

One of his major accomplishments as chief justice of Municipal Court was reorganization of Traffic Court, which the year before was involved in a bail bond scandal.

He was chairman of the Human Relations Board from 1948 to 1960, was a director of the National Conference of Christians and Jews and was active in the **Prisoners Welfare Association.**

Also surviving are a daughter, Mrs. Willard O. Thompson, Cleveland, and four grandchildren. AND DE REFERENCE
