When I first saw this picture in Chicago Magazine, I said to myself, "I know this serial killer."

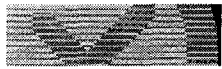
Lester and Judy Munson share their growing family with a holiday picture 1999. A later holiday card made me feel all warm and fuzzy about Lester.

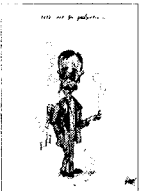

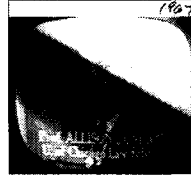

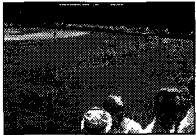

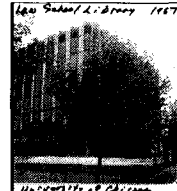

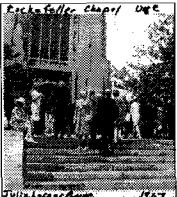

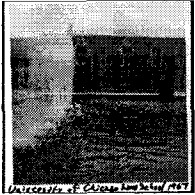

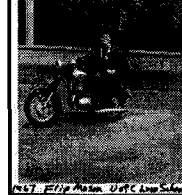

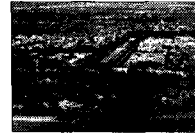

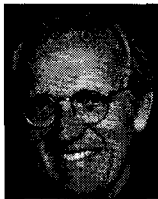

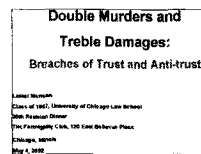
